LISTENING TO OUR CONSUMERS

The Board understands the importance of listening to our consumers to ensure that the strategic decisions we make are in the best interests of every child, young person and family in our care.

The Board is provided monthly with consumer stories, complaints, compliments, and meeting minutes. Invitations to Board meetings are extended on a rotational basis to the Chairs of the Youth, Consumer and Aboriginal Advisory Councils.

This month the Board discussed VEEG Services and minutes from the CAG, YAC and CAMHS LEG meetings. The Board requested:

- The Board requested a status update regarding their recommendation to outsource VEEG services.
- The Board advised that consumer groups should be engaged with regarding common issues from their perspectives.
- The Board enquired into CAHS's efforts to improve ED Neurodiversity Care and sought details on the action plan and implementation timeline.

CAHS Board Communique

This communique provides information regarding the discussions and outcomes from the CAHS Board meeting held on Thursday, 2 November.

KEY ITEMS OF DISCUSSION

- Ward 5A: The Board discussed the model of care, with a focus on community-based treatment and promoting early intervention. The Board discussed the existing challenges and noted the onboarding of a Senior Nurse to oversee the safety and quality of the service on the Ward.
- Clinical Incident Reports: The Board discussed the Clinical Incidents Management Report, with a focus on open disclosure, efficiency of implemented recommendations and relationship building with families where an investigation is being undertaken.
- Nurse-to-patient ratios and supernumerary teams.
- PCH&N Executive Report, The Board requested a thorough review of the PCH theatre capacity and outsourcing so as to maximise services and address elective surgery wait lists.
- Child and Community Health, The Board discussed the progress of an extended/weekend hours trial for Child Development Services and the decision to continue the extended operating hours with consideration at other sites.
- CAHS performance against the **Health Service Performance Report** including PCH demand and capacity.
- Updates regarding the New Women and Babies Hospital;
- Ongoing reform for mental health inpatient services, noting the expected outcomes within 12 months.
- The progress of the **WA Children's Hospice** project.
